#### 4.1 Description of first aid measures.

### **7.1 Precautions for safe handling.**

The fumes are heavier than air and can spread across the ground. They can form explosive mixtures with air. 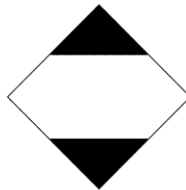
